BASS TOURNAMENT OFFICIAL RULES

- 1) ALL CONTESTANTS MUST ATTEND THE BANQUET ON OCTOBER 23 AND SIGN IN TO BE ELIGIBLE TO FISH.
- 2) A completed entry form signed by both partners must be submitted by mail or at the banquet.
- 3) Tournament hours will be from safe daylight until 3 pm. All boats must check in at a designated site to be announced. Late arrivals will not be allowed to weigh in.
- 4) All contestants will wear a U.S. Coast Guard approved life vest while gasoline engine is on. The kill switch attached when engine is cranked.
- 5) All contestants must obey Alabama Water Safety Rules and Alabama Game and Fish Regulations.
- 6) No, trolling, live bait or fishing withing (50) yards of another contestant that is anchored.
- 7) There will be a 5 fish limit per boat.
- 8) Smith Lake in Alabama has a slot limit of 13-15 inches for black bass (largemouth and spotted bass). This means it's illegal to possess any black bass that fall within that size range. Anglers can keep bass under 13 inches and those over 15 inches. No fish under 12 inches will be weighed or dead fish.
- 9) All live-wells must be checked and boats marked by Tournament officials before leaving ramp.
- 10) Anyone under 18 years of age must be accompanied by an adult.
- 11) If inclement weather conditions exist prior to the start of the Tournament, the Tournament Committee has the right to delay or postpone this event. If inclement weather should arise during said Tournament: it is the Responsibility of the fisherman to take the best action to provide for safety.
- 12) All contestants must remain in boat during Tournament Hours except for emergency.
- 13) No Alcoholic Beverages Allowed.

- 14) Any protest must be brought to the attention of Tournament Directors before prizes are awarded.
- 15) It will be an expressed condition that all contestants abide by any decision or ruling of the Tournament Committee. The Tournament Committee will resolve any condition that is not covered by the above rules.
- 16) There will be No trailering allowed, all boats will launch from Smith Lake Dam.
- 17) This year there will be **NO BLAST OFF**. All participants will check-in and then will be allowed to launch from the boat ramp.
- 18) No fish will be weighed before the scales open. Scales will open at 2 pm.

- 19) **ADULT & CHILD DIVISION** entries are allowed to fish two people per boat with an adult age 21 or older and the child is 14 years and younger.
- 20) We will award the highest **ADULT & CHILD DIVISION** winner \$500. (The **ADULT & CHILD DIVISION** can be the overall winner as well).
